These guidelines are for the purpose of assisting those making a grant or loan application to The William Leech Charity or those seeking grants from The Lady Leech Fund.

The William Leech Charity

The following terms and conditions apply to all funding provided by the William Leech Charity. These terms are designed to ensure that funds are used appropriately and in line with the charity's mission.

grants

Agreement: A grant agreement must be signed by both parties, outlining the grant amount, project details, and reporting requirements.

Use of Funds: Grant funds must be used exclusively for the purpose stated in the application. Any changes to the project or use of funds must be approved by the Trustees.

Reporting: Recipients must provide regular reports as outlined in the Reporting Requirements section.

Audit: The charity reserves the right to audit the use of funds to ensure compliance with the grant agreement.

Refund: If the grant is not used as intended, or if the project is not completed, the charity may request a refund of the grant amount.

Eligibility for grants is focused on registered charities where most of the work is done by volunteers.

Eligible Applicants: Registered charities where at least two-thirds of the work is done by volunteers, excluding administration and fundraising.

Project Focus: Projects that rely heavily on volunteer support and have limited paid staff.

Exclusions: Organisations with substantial paid staff or those that have received recent funding from the charity may not be eligible.

Please note we only accept applications for grants from Registered Charities and community interest companies.

loans

Agreement: A formal loan agreement must be signed by both parties, outlining the loan amount, repayment schedule, and specific terms of use.

Repayment: Loans must be repaid according to the agreed schedule. Early repayment is encouraged to allow the charity to support other projects.

Use of Funds: Loan funds must be used exclusively for the purpose stated in the application. Any deviation requires prior approval from the Trustees.

Reporting: Recipients must provide regular reports as outlined in the Reporting Requirements section.

Default: In the event of non-repayment, the charity reserves the right to take appropriate action, including legal recourse, to recover the loaned funds.

The Lady Leech fund

Terms and conditions for the Lady Leech Fund are similar to those for the William Leech Charity, with additional emphasis on the impact on disadvantaged children.

Agreement: A formal agreement must be signed, outlining the grant amount, project details, and reporting requirements.

Use of Funds: Funds must be used exclusively for the benefit of disadvantaged children in the developing world, as stated in the application.

Reporting: Regular reports must be submitted, with a focus on the impact of the funds.

Audit: The charity reserves the right to audit the project to ensure compliance with the grant agreement.

Refund: If the funds are not used as intended, the charity may request a refund of the grant amount.

Eligibility for grants is focused on registered charities where most of the work is done by volunteers.

Eligible Applicants: Registered charities where at least two-thirds of the work is done by volunteers, excluding administration and fundraising.



funding guidelines

Project Focus: Projects that rely heavily on volunteer support and have limited paid staff.

Exclusions: Organisations with substantial paid staff or those that have received recent funding from the charity may not be eligible.
